**FAMILY COVENANT**

*Carolina Christian School is dedicated to providing a quality education based on the Gospel of Jesus Christ. The Gospel, as taught in the inerrant scriptures, is not just a part of our curriculum but is the foundation of our curriculum. It is our firm conviction that an educational institution founding its academic philosophy on the Gospel will produce an academic program far superior to anything the world can produce. We also believe that children, young men and young women whose minds have been set free by God’s saving grace will excel spiritually and academically to the level that God has uniquely created for each one of them. CCS seeks to enroll families firmly committed to a lifestyle which exemplifies a personal relationship with Jesus Christ and who are serious about educating their children in a Biblical worldview.*

With that in mind, please read carefully the following:

1. I understand that my child(ren) will be taught that salvation and a relationship with God comes only through individual faith in the person and work of Jesus Christ. CCS students will be instructed, encouraged, and expected to live for Christ in every aspect of daily life (thought, word, and deed).
2. I understand that my child(ren) will be encouraged to participate regularly in Bible reading, study and prayer, and I am committed to making weekly worship and Biblical instruction in a local church body a vital part of my family’s life.
3. I agree with and am committed to supporting the purposes, policies, and procedures of CCS. This includes the spiritual, moral, academic, dress and discipline standards set forth in the parent/student handbook.
4. I understand that home and school must work together in our common goal and that communication will be a vital aspect of the success of the school year.
5. I understand that CCS has full discretion in the discipline of my child(ren) within the bounds of the discipline policy set forth in the student handbook.
6. I agree to allow my child to participate in all required field trips and school activities during the school year.
7. I agree to support the school to the best of my ability, in faithful prayer for the administration, faculty and student body, and in offering of practical help and resources to the school.
8. I understand the need for unity and agree to demonstrate only that which is positive and that which would promote a bond of unity and peace. I agree and am committed to the resolution of all problems according to Biblical principles.
9. I understand that enrollment at Carolina Christian is a privilege and not a right. I understand that CCS reserves the right to refuse any application at any time if it is determined by the school administration that the student is not suited to the program offered by the school. CCS reserves the right to dismiss any student whose academic performance or spiritual and moral conduct does not meet the standards expressed in the student handbook.
10. I understand that my child’s application will not be considered until all required forms are submitted and application fee is paid. Further, enrollment in a class is contingent upon all fees being paid in a timely manner.
11. I understand that once my child is accepted, I am committing to CCS payment of tuition and fees for a full academic year, and that all fees (book fees, tuition, and registration) are non-refundable. Further, I agree to the timely payment of all tuition and fees for the academic year. I understand that late fees and NSF fees will apply, and that if my account is 60 days delinquent, I may be asked to remove my student from the school. I understand that CCS will not release any student records until accounts are paid in full.
